

Past High Priest Highlight Thaddeus Scott 1861

SCOTT, Thaddeus was born April 7, 1830 in Cook County, Illinois the son of Willard Scott Sr. and Caroline Hawley. He married Eleanor Butler May 16, 1849 in Naperville and they were the parents of a son, William Hawley. He was employed in his father's business, Willard Scott & Sons, a banking and exchange concern. He served as Naperville Township Collector in 1852. He was raised a Master Mason May 16, 1853. He was exalted a Royal Arch Mason November 11, 1853 and served as High Priest in 1861. He travelled to New York City in March of 1866 on business and died there accidentally while eating his dinner on March 30, 1866. He



was buried in the Naperville Cemetery with usual Masonic ceremony.



Charitable Contribution Subcommittee report - summary

Working under the guidance of the finance committee, a working group was assembled to look at worthy charitable organizations, which would then be considered viable recipients of a portion of the Lodge's available charity funds. Donations to the charity fund have been larger than usual this year, and combined with the carryover of funds from the past years has resulted in a fund balance in excess of \$5000.



The working group, which consisted of Bros. Bruce Derylo, Derek McDaniel, and Bill Shazer III provided the following group of prospective recipients:

Naperville Responds for Veterans (NRFV)

Naperville Responds for Veterans assists Veterans and their families in need, especially those with low and moderate income, by raising donations of money, building materials, and professional labor; and coordinating the process of repairing, building and donating homes.

A Man in Recovery

A Man in Recovery seeks to inform and aid families of addicts, at-risk youth, educators, employers and legislators about recovery from opiates, especially heroin. The Heroin Epidemic is real, and growing – primarily because it's cheap and readily available to young people and others who get hooked on it.

Conservation Foundation - Naperville

The Conservation Foundation is a non-profit land and river protection organization founded in 1972.
