Wbro. Cowart coordinated speakers who gave interesting and informative presentations of a Masonic nature for all of our stated meetings.

I provided Intender Training and Investigation Committee Member training in January for all members who were interested. In addition, I have been busy with the Grand Lodge Committee on Education, helping to put together a Power Point presentation for Intender Training. Once that project is complete, the committee will start work on a training program for Investigation Committees.

The Table Lodge held in June was not only entertaining but also very informative, with members of the Lodge taking part in the various rehearsals, responses and discourses related to the three degrees.

We all had a very enjoyable time traveling to Hinsdale Lodge and capturing the 10th Northeastern Traveling Gavel. We were able to muster up 22 of our members, narrowly overtaking the home Lodge's 21 members present. It was a great show of support for our Lodge.

The Lodge sponsors the Naperville North High School Academic Team in the Masonic Academic Bowl. Our members came out in force once again and provided the team with moral support during the competition. We have added sponsorship of the Naperville Central High School Academic Team this year and look forward to cheering both of these teams on.

The Lodge was busy with degree work this year, initiating 12 Entered Apprentices, passing 9 Fellowcrafts and raising 6 Master Masons.

I have decided to jump from the frying pan into the fire. I will be taking over as Secretary of the Lodge, (if elected) and have some very large shoes to fill. Although according to Bro. Behr, they are not really that big, since they are only 10 and a halves.

Past Master Highlight Roy Edwin Brown 1936

Ray Edwin Brown was born July 9, 1899 in Big Stone City, Grant County, South Dakota the son of Reverend Samuel Faese Brown and Sarah Wilhelmina Schutz. He attended the Northwestern College Academy, graduating in 1919. He married Esther Sophia Ultch about 1923 and they were the parents of a daughter, Geraldine Mae. He was employed by the Kroehler Manufacturing Company in Naperville, Kankakee and Binghamton, New York as a clerk in the Collections Department and also as the Time-keeper and Paymaster. He was raised a Master Mason October 26, 1925 and served as Master of the Lodge in 1936. He also served as Secretary of the Lodge in 1933, Junior Warden in 1934, Senior Warden in 1935 and Chaplain in 1937. He died September 10, 1984 in Livermore, Alameda County, California and was buried in the Restland Cemetery, Mendota, LaSalle County, Illinois.

History of Veterans Day

World War I – known at the time as "The Great War" - officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars."

In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..."

The original concept for the celebration was for a day observed with

parades and public meetings and a brief suspension of business beginning at 11:00 a.m.

The United States Congress officially recognized the end of World War I when it passed a concurrent resolution on June 4, 1926, with these words:

Whereas the 11th of November 1918, marked the cessation of the most destructive, sanguinary, and far reaching war in human annals and the resumption by the people of the United States of peaceful relations with other nations, which we hope may never again be severed. and

Whereas it is fitting that the recurring anniversary of this date should be commemorated with thanksgiving and prayer and exercises designed to perpetuate peace through good will and mutual understanding between nations; and

Whereas the legislatures of twenty-seven of our States have already declared November 11 to be a legal holiday: Therefore be it Resolved by the Senate (the House of Representatives concurring). that the President of the United States is requested to issue a proc-

lamation calling upon the officials to display the flag of the United States on all Government buildings on November 11 and inviting the people of the United States to observe the day in schools and churches, or other suitable places, with appropriate ceremonies of friendly relations with all other peoples.

An Act (52 Stat. 351; 5 U. S. Code, Sec. 87a) approved May 13, 1938, made the 11th of November in each year a legal holiday—a day to be dedicated to the cause of world peace and to be thereafter celebrated and known as "Armistice Day." Armistice Day was primarily a day set aside to honor veterans of World War I, but in 1954, after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83rd Congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans." With the approval of this legislation (Public Law 380) on June 1, 1954, November 11th became a day to honor American veterans of all wars.

Later that same year, on October 8th, President Dwight D. Eisenhower issued the first "Veterans Day Proclamation" which stated: "In order to insure proper and widespread observance of this anniversary, all veterans, all veterans' organizations, and the entire citizenry will wish to join hands in the common purpose. Toward this end, I am designating the Administrator of Veterans' Affairs as Chairman of a Veterans Day National Committee, which shall include such other persons as the Chairman may select, and which will coordinate at the national level necessary planning for the observance. I am also requesting the heads of all departments and agencies of the Executive branch of the Government to assist the National Committee in every way possible."

On that same day, President Eisenhower sent a letter to the Honorable Harvey V. Higley, Administrator of Veterans' Affairs (VA), designating him as Chairman of the Veterans Day National Committee. In 1958, the White House advised VA's General Counsel that the 1954 designation of the VA Administrator as Chairman of the Veterans Day National Committee applied to all subsequent VA Administrators. Since March 1989 when VA was elevated to a cabinet level department, the Secretary of Veterans Affairs has served as the committee's chairman.

The Uniform Holiday Bill (Public Law 90-363 (82 Stat. 250)) was signed on June 28, 1968, and was intended to ensure three-day weekends for Federal employees by celebrating four national holidays on Mondays: Washington's Birthday, Memorial Day, Veterans Day, and Columbus Day. It was thought that these extended weekends would encourage travel, recreational and cultural activities and stimulate greater industrial and commercial production. Many states did not agree with this decision and continued to celebrate the holidays on their original dates.

The first Veterans Day under the new law was observed with much confusion on October 25, 1971. It was quite apparent that the commemoration of this day was a matter of historic and patriotic significance to a great number of our citizens, and so on September 20th. 1975, President Gerald R. Ford signed Public Law 94-97 (89 Stat. 479), which returned the annual observance of Veterans Day to its original date of November 11, beginning in 1978. This action supported the desires of the overwhelming majority of state legislatures, all major veterans service organizations and the American people. Veterans Day continues to be observed on November 11, regardless of what day of the week on which it falls. The restoration of the observance of Veterans Day to November 11 not only preserves the historical significance of the date, but helps focus attention on the important purpose of Veterans Day: A celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good.

Ancient Free and Accepted Masons

How did the words "free" and "accepted" originate? The ancient craftsmen were very skilled, and their craft was considered to be indispensable to the welfare of both church and state. For this reason, they were not placed under the same restrictions of other workers. They were "free" to do their work, travel, and live their lives in a manner which befitted their importance.

In medieval England, this freedom of movement was almost unheard of. Most workers were under bond to the owners of the land on which they worked. We believe this freedom for the operative mason may date back as far as the year 946 in York, England.

The word "accepted" also goes back to the time of the operative mason. During the latter years of the Middle Ages, there were few educated men outside the monasteries of the church. Naturally, men wanted to become Freemasons to get the advantages the Craft had to offer. These men did not necessarily want to build buildings but they wanted to belong to the organization.

These were "accepted" Masons rather than operative masons. This practice probably originated when some of the people for whom craftsmen were working asked to be admitted and the practice grew with time. This was a big boost to Masonry, because the secret techniques of building trades were becoming more widely known, the requirements of architecture were changing, and our operative membership was declining.

As time went on, there became more and more accepted members than there were operative members. Sometime in the late seventeenth century, we believe the accepted Masons may have outnumbered the operative masons, and we eventually became a speculative organization rather than an operative one.
