Past Master Highlight Harold Emery Meiley 1951

Harold Emery Meiley was born March 9, 1906 in Naperville, DuPage County, Illinois the son of Emery Gay Meiley and Laura Nevada Sheldon. He married Claudia Heath Carter May 9, 1936 and they were the parents of two children, Judy Gay and Claudia Jeanne. Claudia died April 6, 1940 and he married Janet Carolyn Lehman September 18, 1940 and they were the parents of two sons, Emery and Charles. He was employed as a real estate and insurance broker. He was raised a Master Mason May 5, 1947 in Euclid Lodge and served as Master in 1952. He was a Grand Lecturer and served on the Board of Grand Examiners for the Grand Lodge of Illinois. He was exalted a Royal Arch Mason April 9, in Euclid Chapter No. 13, Royal Arch Masons. He was also a member of the Aurora Commandery No. 22, Knights Templar, the Scottish Rite, of which he was the instructor for the degree team, past District Deputy Grand Master of the 31st District, the Shriners Medinah Temple, Althea Chapter No. 206, Order of Eastern Star and the Naperville Moose Lodge. He died April 29, 1961 in Morris, Grundy County, Illinois the result of an automobile accident on his way to a Masonic Lodge meeting. He was buried in the Naperville Cemetery.

N. TRACY WALKER SCHOLARSHIP FUND



Norman Tracy Walker was born February 23, 1921 in Lemont, Cook County, Illinois the son of George Simpson Walker and Theresa Schmelzer. He married Myra Garrett Twichell December 29, 1948 in Lockport, Illinois and they were the parents of two daughters, Georgia and Myra. He was a Veteran of World War II and the Korean War. He was the President of the Lemont National Bank, and also a member of, and affiliated with, numerous civic, charitable and Masonic organizations, nationally and internationally. He was the founder and a charter member of Arboretum Lodge No. 1175 and served as Master of the Lodge in 1977 to 1979. He died November 26, 1984 in Lemont, Cook County, Illinois and was buried in the Fairmont - Willow Hills Cemetery, Willow Springs, Illinois.

In 1979, one of the members of Arboretum Masonic Lodge No. 1175 suggested that the Lodge should do something special to give back to the community. It was decided to honor the top ten percent of the Lisle High School graduating class with a dinner along with a distinguished guest speaker. The lodge was new and had limited funds at that time so each of the fifty members was asked to sponsor one graduate for dinner at a cost of \$12.50.

The dinner was a success for quite a few years and although membership in the Lodge fell off, the funds earmarked for this event continued to grow. The dinners were eventually discontinued but lodge members still wished to acknowledge in some way those students for their fine efforts. This was the beginning of the N. Tracy Walker Scholarship Fund and the first college scholarship grant was awarded in 1996. The fund continues today in awarding scholarships to those High School Seniors who meet the criteria of the organization.

The fund originally helped seniors at Lisle High School. In recent years it was amended to help seniors from the Naperville High School District. This year it has been expanded to include any senior within the State of Illinois.

The officers of the fund are Worshipful Brothers Paul S. Perkins, President; David A. Oakes, Treasurer; and John E. Buckler, Secretary.

If you know of a High School Senior in the State of Illinois that meets the following criteria and would like to apply for a college scholarship grant, have the student fill out an application and include with it two letters of recommendation from teachers and an official school transcript listing the students current GPA.

"To be eligible to receive a scholarship grant, the candidate must be: (a) student of a High School in the State of Illinois with strong community involvement, (b) in the top 10% of the student's class as determined by GPA, and (c) must have a grandfather, father or brother who is a member in good standing (or is deceased, was a member in good standing at time of death) of The Grand Lodge of Illinois A.F. & A.M. of the Masonic fraternity."

Applications must be mailed no later than March 31st to the address shown below.

The Cabletow

According to the ancient laws of Freemasons, every brother must attend his lodge if within the length of a cabletow or a cables length. It was taken to be three miles for an Entered Apprentice. Originally, the cabletow was as long as an hour's journey or three miles. The word is seldom found in dictionaries. It is peculiarly Masonic. The word "cable" refers to a rope; the word "tow" refers to drag. Masonically, it is the scope of a man's reason or ability to accomplish his object. A cabletow may have many lengths according to the man's ability or the scope of his desires. Cabletow is a general term with no set length. It may be said, it is the length of a man's conscience between himself and his God. You are your own judge and jury.

Masonically, this word has many definitions, from the original CONSTITUTIONS it was intended to mean three miles. By 1785 it meant a day's journey. By the turn of the century (1800) it was defined as the distance a man could reasonably travel to his lodge on meeting nights. Some lodges even mentioned the requirement in their by-laws (within the town or city limits).

Originally, (1717) it was called cable-rope. Then it was changed in the old ritual to cable-tau, which was defined as being taken from the German KABEL TAU and in German this meant the cord which attached the infant to its mother when first born. Symbolically, to the early Masons it meant the tie between the initiate and his mother lodge. At the Baltimore Convention it was defined, "the scope of a man's reasonable ability."
